The meeting agenda will include treasury report, road repairs, Board elections, and new business.

Roads

In March, the SRPOA Board approved a proposal by several property owners to improve the road, focusing primarily on the road segment from the end of pavement to the cattle guard, secondarily on the segment from the cattle guard to the rise after the 2 low water crossings, and as time allows, from that rise to the Y at Yancey Creek Rd. Material funds were also allocated to North, Mid, and South River Roads. You can read more details in the meeting minutes posted at the SRPOA website. Hopefully, by the time you read this letter, the road will be in better condition!

Fire

We have been blessed with abundant rain over the last year, but this land has been hit hard by drought, and many areas are filled with dead cedars. Leadership

The Smith Ranch Property Owners Association exists primarily to maintain Main and Yancy Creek Roads from the end of CR1287 to the river, and to pay taxes and insurance for the common areas.
